2. All VIRTUAL only accepted submissions will be in the virtual online exhibit only.
3. The awards for virtual only are ONE People's Choice Award - \$50 via ONLINE VOTE
4. The awards for in person are listed below.

Different appointed jury teams choose the accepted artwork each month.

Accepted artwork will be on exhibit starting Wed, April 20th for up to three weeks.

4th Fridays puts 400–1000 people past your artwork in one amazing art event experience.

**Jpeg Preparation**

Formatting your image files prior to submission:

1. jpgs in standard format, with the LONGEST SIDE AT EXACTLY 2100 px
  2. JPGS MUST BE LABELED: yourlastname firstname art title.jpg
- [please add a number at the title end IF submitting more than one untitled piece – ie -

jones\_me\_untitled1.jpg; jones\_me\_untitled2.jpg]

3. 3d work allowed up to 3 jpg files to represent ea piece. 2d work allowed only 1 jpg file per piece.

### **Online Submissions**

Important - Before submitting, have your image files ready to attach.

1. TYPE the url [www.nancymerkling.com](http://www.nancymerkling.com) in your browser.
2. Click on the second section on the website that says 4th Fridays
3. Follow the leads from there.

### **Photography Framing Specs**

All photos must be presented in an 11x14 simple black frame with a white mat. Your photo can be any size within the mat. Work must be wired to hang [no saw tooth hangers] with a label affixed to the back with the artist's name, title of work and sale price. Artwork must be professionally presented. "4<sup>th</sup> Fridays" and the curator reserve the right to reject any artwork that is deemed unsuitable including but not exclusive of work not ready to hang, unprofessional presentation, concern for the condition of the piece.

### **Eligibility and Conditions**

ACCEPTANCE IN THE EXHIBIT IS NOT GUARANTEED.

Original works executed by the artist which have not been previously displayed in our 4th Fridays exhibition are eligible. Paintings, sculpture, prints, drawings, textiles, photographs, jewelry, and mixed medium pieces are acceptable. Eligibility of installation artwork will be considered on an individual basis with the responsibility of the install resting on the artist within the schedule confines of the "4th Friday" installation. No dimension of any work may exceed 8 feet in either direction and not exceed 150 pounds. Must be able to fit through a 35" x 83" door. Incomplete entries will not be considered nor fees refunded. Entry fee is non-refundable nor transferable. Accepted works must be hand delivered. No shipments will be received.

### **Artist Guidelines**

- Artwork must be wired to hang [no saw tooth].
  - A label must be affixed to the back with the artist's name, work title, and sale price.
  - Artwork must be professionally presented.
- 4th Fridays and the curator reserve the right to reject any artwork that is deemed unsuitable including but not exclusive of work not ready to hang, unprofessional presentation, concern for condition of the piece, representation different from jpg to actual print.
  - Substitutions of artwork are not allowed.

- All accepted work must be for sale and will be subject to a 30% commission if sold. Payments to the artists will be issued from our accounting department within 1 week of the sale.
- Although 4th Fridays will make every reasonable effort to protect your work while it is in our possession, we are not legally responsible for it. Therefore, consider insuring your work while it is in our possession.
- Submitted artwork may be used for exhibition purposes and publicity.
- Work must remain hanging throughout the duration of the 4th Friday show until 9:00 pm. If you choose to take your work home at the end of the event instead of the extended exhibit time, arrangements must be sent in an email to : [nancy@nancymerkling.com](mailto:nancy@nancymerkling.com)
- If you are unable to pick up your work during the noted time, other arrangements must be made in advance.
- Uncollected work becomes property of 4th Fridays seven days after pick up deadline.

### **Your Moral Compass**

If potential buyers approach you during the event wanting to cut a deal after the event to save them the 30% commission, not cool, right? And if a buyer should connect with you within 3 weeks after the event because they saw your work AT the event, we ask that you direct the handling of the sale through the event as it would not have happened without our promoting the work.

4th Fridays acts as an agent for the artists to submit, exhibit and sell artwork. Sales tax is collected and paid on each sale. Artists are responsible for compliance with their own income taxes on the sale of their artwork.
